137. Traffic Accident, Sychnant Pass Road, 28/9/16

Members discussed traffic speed issues on Sychnant Pass Road following an accident on 28th September 2016.

A Public Meeting had been held that highlighted a number of incidences.

Members were informed that the County Council collates evidence from the police before deciding to upgrade a road for safety. Attendees at the Public Meeting had said that they did not know how to report incidences as the police would often not attend. The public are concerned about increased traffic in the light of the proposed housing development on Sychnant Pass.

Members were told that they should ask for a reference number if they report anything to the police or County Council. This should ensure that the incidence has been recorded.

138. Temporary Closure of Footpaths in Llandudno Junction

The Town Clerk informed Members that the proposed closures of Footpaths 29 & 30 had both been cancelled until further notice

139. Bus Shelters

The Town Clerk presented a list of cleaning & repairs required to the community bus shelters following the survey by Senior Public & Community Transport Officer, CCBC, a representative from Externiture Ltd. & herself.

The total cost of repairs was quoted at £11,192.07. This included shelters at Broad Street, Llandudno Junction & Brynmaelgwyn Cottages, Deganwy that could possibly removed, following usage research. The cost excluding these two shelters would be £6,055.75. This amount would be covered by the contribution to bus shelter maintenance currently held by the County Council.

Members also asked about the status of the redundant bus shelter at Gorlan which is no longer on a bus route. The Town Clerk informed Members that this shelter was being considered for relocation to Glyn-y-Marl Road, Llandudno Junction, to possibly replace a Clear Channel shelter that had been removed following the breakage of the glass panels

RESOLVED that:

- a) the work excluding the Broad Street & Brynmaelgwyn Cottages shelters is approved
- b) the County Council is asked to relocate the Gorlan shelter to Glyn-y-Marl Road if Clear Channel do not go ahead with the replacement
