3. Local Government Pension Scheme - New Fair Deal Consultation

Please see below an email from the Ministry of Housing, Communities and Local Government in respect of a consultation on the proposed amendments to the Local Government Pension Scheme that are intended to implement the New Fair Deal Policy protecting the pensions position of local government workers who are compulsorily transferred as part of an outsourcing arrangement. On the new Fair Deal consultation front, the key elements include: •Defining those scheme employers that would be directly impacted by the proposed changes; •Confirming the removal of the ability for contractors to offer the alternative of a broadly comparable scheme as a means of securing pension protection; •Confirming the transitional arrangements protecting those individuals whose pension protection was previously gained via early provisions; •The proposed introduction of "deemed employer" status as an alternative option to "admitted body" status; and • Introducing guidance to assist employers in understanding their responsibilities. In addition to changes linked to new Fair Deal into the LGPS, the Government has also taken the opportunity, as part of this consultation, to consider changes aimed at smoothing arrangements where scheme employers are involved in mergers or takeovers (e.g. academies, FE colleges). We look after the pipes that keep the gas flowing to heat homes and power businesses across Wales and the south west of England. 7.5m people rely on us every day. I just wanted to let you know the precautions we were taking to make sure we continue to deliver for your constituents. •Our Winter Preparedness Plan has been invoked: that means that all our first responders are on alert and ready if needed. If used, they allow our Emergency Engineers to focus on gas emergencies. •We've made sure that all our 4x4 and all-terrain vehicles are in place and ready for use by our emergency engineers. We'll use them instead of vans to get to gas emergencies if the roads become impassable. •Additional colleagues will be transferred to areas worst hit by the weather, and all non-essential planned work for Friday has been postponed. We've also launched a social media campaign reminding people who to contact if they have problems with their heating or their gas supply over the next few days. If you have frozen boiler condensate pipes you can try and defrost them yourself using heat wraps or warm water but if this doesn't work please call a Gas Safe Registered engineer or your gas supplier.
