Mr Holden-Ross was unable to attend the meeting. The agenda item is deferred to a future meeting.

The following two agenda items were allowed by the Chairman as a matter of urgency

71. Confidential Business

In accordance with the Public Bodies (Admission to Meetings Act) 1960 and with Standing Order 65, in view of the confidential nature of the business about to be transacted, it is advisable in the public interest that the press and public be temporarily excluded and instructed to withdraw.

72. Conwy Civic Hall and Quay

Members discussed the decision by Conwy County Council Cabinet at their meeting on 14th July 2015 to Dispose of the Civic Hall, Conwy along with part of the Quay. The intention is to sell the lease to a Developer for a restaurant, possibly with bedrooms and have an outdoor seating area on the Quay. The Town Clerk updated Members on the matter. The two County Councillors for Conwy have been Appointed to the Project Board but the request for a Town Councillor to be on the Board was not mentioned. Mr. Peters of Conwy County Borough Council said that he was unable to release a copy of the presentation made to the Town Council at the Special Meeting of the Council on 6th July 2015. The Town Clerk had collated and forwarded the views of 3 Town Councillors to Mr Peters prior to the Cabinet meeting.

Members thanked Councillors Allardice and Edwards for speaking on behalf of the Town Council at the Cabinet meeting.

Members felt that the County Council's attitude to the Town Council was disrespectful and degrading. They had misinterpreted the Town Council's views passed on to them by Conwy County Borough Council's Officers, missing the fact that the Town Council recognises that the Civic Hall needs to be developed. The Town Council is not opposed to job creation but Members felt that they were portrayed as anti-business. Any development needs to be in keeping with the town. Comments by County Councillors dwelled upon the seagull issue and references were made about Dylans.

Members discussed how the Town Council should respond to the decision at the meeting.

The main concern of the Town Council is the intention to dispose of part of the Events Space. Members

felt that if it was part of the project, then any lease should only be for a few years – not a long term. Members questioned the ownership of the Quay and whether it was Conwy County Borough Council's to sell.

Members discussed the Grade II listing and were told that it applied to the whole of the building. Members felt that any developer would need to improve the façade of the roof area.

Members discussed how other walled towns around Europe have cleared their town walls, or would like to clear their wall. Derry, Northern Ireland are upset that their town wall is hidden. Buildings in Conwy were demolished to reveal the Town Wall.

Members stated that Conwy County Borough Council seemed uninterested in the suggested space above the toilets for outside eating and were not interested in keeping the Events Space for displaying Conwy's history and culture of boat-building.

Members are reflecting the views of residents and making decisions in the best interests of the community. Members talked about the Charter between the County Council and Town & Community Councils, feeling that the County Council was not working with the Town Council for the benefit of the community. Members were informed that the designated area for a "community picnic area" is the area close to the

Members said that they thought more bedroom space in Conwy would be beneficial, but doubted that more eateries were needed. Events on the Quay will attract more visitors to the town and bring jobs.

RESOLVED that:

- a) A letter is written to Conwy County Borough Council stating that the Town Council is disappointed about the way it was conveyed in the Cabinet meeting. It was felt that it was referred to using derogatory terminology and that comments made in the Special Meeting of the Council on 6th July 2015 were not conveyed accurately by Conwy County Council Officers. The Town Clerk will circulate a draft copy of the letter to Members prior to sending it to Conwy County Borough Council.
- b) A copy of the letter is sent to Cadw and UNESCO
- c) The pricing strategy for the hire of the Events Space is requested
- d) Conwy County Borough Council are asked who owns the Quay
- e) The Mayor speaks to Town Council Members in other towns regarding County Council running of assets in their areas.

The Mayor, Councillor Allardice and the Assistant to the Town Clerk left the meeting at this juncture.

The Press and Public were allowed to rejoin the meeting

74. Questions on the Minutes

a) Special Meeting of the Council, 6th July 2016

i)Minute 52, Casual Vacancy, Deganwy Ward

The Town Clerk informed Members that the County Council had received the 10 signatures required to call an election. The County Council will arrange this for the end of September/beginning of October.

ii) Minute 55, Proposal for Naming of a Street

The name "Dros Mynach" was questioned. The Town Clerk informed Members that County Councillor M Hughes had objected to the developers suggestion and that they had been asked to choose one from the list given to them in 2014

iii) Minute 59, Parking Prohibition - Castle Square, Conwy

The Town Clerk informed Members that she had emailed Mr Brookes, Conwy County Council regarding coaches ignoring the prohibition. He said that coach companies had been emailed, asking them not to drop off by the Castle, but to use the drop-off point in Rose Hill Street. He was against the addition of yellow lines being painted on the road.

iv)Minute 61, Ward Meetings

- -The Town Clerk informed Members that she had reported the damage to the Adshel bus shelter by the Weekly News, Llandudno Junction
- -The town Clerk is still to ask the police to attend a meeting

v)Minute 67, Hire of Guildhall

The Town Clerk informed Members that she had informed the person that they were unable to hire the Guildhall and that he had not taken the news well. Members felt that it needed to be stressed that the Guildhall is not open to the public.

RESOLVED that Members unanimously support the Town Clerk in her dealings with this matter.

b) Extraordinary Meeting of the Council, 13th July 2015

Minute 2, Honorary Bailies

- -Councillor Macdonald informed Members that the Charter had now been printed and that she would arrange for 3 copies to be framed.
- -The Town Clerk informed Members that she had selected a paperweight from Welsh Royal Crystal at a cost of £28 per unit, including engraving and that she would place an order for 100. Members suggested that a sample should be requested for checking and that the paperweights are boxed.

- d) A copy of the Pioneers Post and the CVSC July Newsletter are on the Chamber table in the Guildhall
- e) Rural Community Development Fund The RCDF element of the Wales Rural Development Programme 2014-20 is set to be opened at the Royal Welsh Show at Builth Wells week beginning the 20/7/15. This will be a grant scheme to be administered by the Welsh Government and will offer grants to organisations/groups for investment funding across a wide range of interventions designed primarily to mitigate the impact of poverty in rural communities, improving conditions which can lead to future jobs and growth. This will be a capital only scheme defined as anything costing over £10k, with 7 broad themes.
- f) The Royal Cambrian Academy Annual Summer Exhibition opens at 2pm on 25/7/15.

77. North Wales Link of the Walled Towns Friendship Circle

RESOLVED that the payment of £125 for the 2015/16 subscription is approved.

78. European Walled Towns – Annual General Meeting/Seminar, Ravenna Italy, 20/9/15 to 3/10/15

Members RECEIVED details of the AGM/Seminar. The public is permitted to attend the AGM.

Councillor Macdonald is attending as an Associate Member and Councillor Chapman is also attending and will be able to represent the Town Council.

Councillor Macdonald said that she did not want to be nominated for the position of Vice President, but would think about possible nominees.

79. The Castles & Town Walls of King Edward in Gwynedd World Heritage Site New Governance Arrangements & Development of a New Management Plan

Members RECEIVED details of the proposed Steering Group, to include 2 representatives from Conwy, Caernarfon, Beaumaris and Harlech

RESOLVED that:

- -a request is made that a representative from Conwy sits on the Steering Group due to the issues faced in the town
- -if a representative is permitted, Councillor Chapman attends the meetings with Councillor E Hughes in reserve.

80. Hanging Baskets – Watering

Members discussed purchasing devices to place in hanging baskets to water them on days the businesses are unable to water them. This is not an alternative to regular watering.

RESOLVED that the Town Clerk carries out more research as to where the waterers can be purchased from.

81. Cycling between Conwy & Llandudno Junction

Members RECEIVED a proposal from Conwy County Borough Council to allow cyclists to legally use the footway between Conwy and Llandudno Junction.

Members felt that there was not enough room on the Conwy Bridge footway to allow for cyclists and pedestrians and to maintain everyone's safety they felt that cyclists should be asked to dismount when going over the Bridge.

RESOLVED that the Town Council supports cycling on the route, apart from the Bridge, where cyclists should be asked to dismount.

82. Conwy Quay

The Town Clerk informed Members that she had received reports that cars were continuing to drive along the Quay at prohibited times and that it was not being policed.

RESOLVED that the Town Clerk writes to the Police, Harbourmaster and Conwy County Borough Council Highways Department requesting that the prohibition is policed.

83. Llywelyn Fountain

The Town Clerk informed Members that she had written to Mr. Teale, Conwy County Borough Council requesting a quote for a regular maintenance programme for the Fountain. This may avoid delays in getting the Fountain running again after a breakdown.

Complaints about the Fountain not working are being received.

The invoice for maintenance for May 2015 from Conwy County Borough Council is £118.50 plus vat Members were concerned that the chemicals being used in the Fountain may be affecting the stonework **RESOLVED** that the invoice for £118.50 plus vat is approved for payment.

84. Conwy Street Cleaner

Members RECEIVED information that Conwy County Borough Council planned to re-deploy Mr Kelfyn Williams the Conwy Street Cleaner, elsewhere in the county. Members said that Mr Williams was doing an excellent job keeping the town clean and tidy.

RESOLVED that the Town Clerk writes to the County Council to tell them that Mr Williams is doing an excellent job and requesting that they let him stay in Conwy.
