1. Conwy County Borough Council

2. Llangollen International Musical Eisteddfod

What a fantastic week Llangollen 2016 turned out to be! With reasonable weather and visitors witnessing some of the best competitive groups for some years, it was an International Eisteddfod that showcased Wales as a warm, friendly & welcoming country to visit. The week began with the sensational performance of 'Carmen' by Kate Aldrich, whose expertise as the leading lady brought such wealth to the performance. We were extremely lucky to get Kate at the last minute as a replacement after Katherine Jenkins was forced to withdraw from the concert due to ill health. As they say 'the show must go on' and it most certainly did, with both Kate & local favourite Noah Stewart giving the audience a night they will treasure forever. Other highlights from the week included the Phizz-whizzing Big Friendly Concert in celebration of the centenary of Roald Dahl's birth. Many visitors enjoyed the 70th Classical Gala Concert starring Bryn Terfel & Joseph Calleja that much they never wanted the night to end! Staging an internationally renowned Festival is a financially challenging task & we are grateful for all the support that the Local Authorities, Town & Community Councils continue to give us during these times of cuts. As you can see from an insight into Llangollen 2016 that I have shared with you above, Llangollen really does benefit the whole of Wales & we know that you share that ideal. We would like to respectfully ask the Local Authorities, Town & Community Councils who support us to continue & with this funding help to keep Wales on the world Festival map. 3. One Voice Wales - National Conference report

Cabinet Secretary proposes very positive developments for the Community & Town Council Sector in Wales. One Voice Wales held another successful National Conference at the Royal Welsh Showground on 1/10/16 with 170 delegates present, 16 supplier companies exhibiting & three great presentations from Mark Drakeford AM the Cabinet Secretary for Finance & Local Government, Stephen Mulholland & Julie May of the Independent Remuneration Panel for Wales (IRPW) & Peter Davies CBE, Chair of the Wales Council for Voluntary Action (WCVA). One Voice Wales will be working with the IRPW in the months ahead supporting their consultations with the local council sector & with the WCVA on closer partnership working between local councils & the Third Sector. In his keynote address to Conference Mark Drakeford AM Cabinet Secretary for Finance & Local Government set out the challenges facing local government brought about by the current financial climate. He sent out a very positive message that community & town councils had a very important role to play in the future of public services provision & proposed an initial eight point action plan for the local council sector in Wales. The eight proposals to build resilience & renewal in community & town councils are set out below: 1. Produce a toolkit to support community councils in working through what is required in

- Produce a toolkit to support community councils in working through what is required in taking on new services & assets, building on experiences of the key ingredients
- 2. Press ahead with legislating for the General Power of Competence, shaped by the suggestions made in response to the previous Government's consultation, for innovative ambitious councils looking for more freedom to serve their communities.
- 3. Re-energise ties between community councils & local authorities & provide a platform to share the good examples across Wales, bringing the new cadre of county & community councillors together after the Local Government elections next year at a conference

focused on strengthening these key relationships 4. Facilitate the creation of clusters of smaller community councils, making some modest funding available to support the initial setting up of joint arrangements. 5. Legislate to make it an obligation on councils to consider and plan for their training needs & review it regularly. 6. Ensure citizens are kept informed & have the right to make representations on any business conducted at a council meeting. Learn from where this is done well & look for a legislative opportunity to strengthen current provisions. 7. Commission the Local Democracy & Boundary Commission to draw up guidelines for local authorities to secure consistency in the manner in which community reviews are conducted. 8. Support community councils to raise awareness & encourage participation in community council elections & to increase diversity, with an initial focus on the elections in 2017 One Voice Wales will be working with the Cabinet Secretary, Welsh Government & stakeholder organisations in taking forward these proposals.

4. Consultation on policing priorities

Consultation on policing priorities – delivering a policing service for the whole of North Wales. The Police & Crime Plan will set the objectives & strategic direction for North Wales Police during my period in office as Police & Crime Commissioner. I meet with several individuals & organisations on a day to day basis & I do listen to their concerns & how we can improve the policing service. Between 17/10/16 & 16/12/16 I will be collecting your views on policing priorities which will help me prepare the Police & Crime Plan. I will be holding a range of public events across North Wales, the details of which can be found on our 'public meetings' webpage or you can of course contact my office by phoning 01492 805486. The Chief Constable &/or Deputy Chief Constable will also be in attendance at some of these events. There is also a short online survey you can complete to let me know what you think, it should only take you a few minutes to complete. Your views are invaluable to me to ensure that we have a policing service in this area that reflects the needs of the people of North Wales.

5. National Infrastructure Commission for Wales

The Welsh Government wants a better informed, longer-term strategy of investment in infrastructure which enshrines the principles of the Well-Being of Future Generations Act. We also wish to enable more efficient development of specific projects & enhance our ability to achieve value for money for public sector investment. That is why we have made the commitment to establish a National Infrastructure Commission for Wales to provide us with independent & expert advice on strategic infrastructure needs & priorities. The Cabinet Secretary for Economy & Infrastructure, Ken Skates AM, is today launching a public consultation that invites stakeholder views on how the commission could be set up & run.
