# CYNGOR TREF CONWY TOWN COUNCIL THE GUILDHALL, CONWY. MINUTES OF THE SPECIAL MEETING OF THE COUNCIL HELD ON MONDAY 25<sup>th</sup> MARCH 2019

Agenda item 8a, Planning Applications – Councillor M Priestley is a member of Conwy County Borough Council Planning Committee.

Agenda item 8a, Planning Applications – 0/46024 – Councillors H Roberts & E Roberts live in the locality of the premises.

## 137. Dog Walking Community Parks

Members received a presentation from Ms L Martin, Regulatory Services, CCBC. Regulatory Services are planning to install 2 dog walking areas in Conwy Town where dog fouling, dog control and dog attacks are high. They have also asked the Town Council to suggest areas for Dog Parks in Llandudno Junction and Deganwy. CCBC have obtained sponsorship for the dog parks from the Pet Place, Abergele, who will provide welfare stations, bins, toys and help to publicise the area. Conwy Town Council are expected to take on full maintenance of the Parks once they are open.

Members suggested that a public consultation is held before moving further. Ms L Martin explained that the next step is to finalise costings and will bring the item back to a future agenda.

The Chair thanked Ms L Martin for her presentation.

#### 138. Minutes

Minutes of the Town Council Meeting held on 11<sup>th</sup> March 2019.
 RESOLVED that the minutes are ACCEPTED and APPROVED with the following amendment – Minute 115. 21<sup>st</sup> Century Schools in Deganwy Project Board – plans to develop the School.

#### 139. Questions on the Minutes

i) Minute 121. Honorary Bailies 2019/20

The Town Clerk informed Members that both Margaret Norwood and Peter McFadden had accepted the honour of Honorary Bailie.

ii) Minute 129. Hanging Baskets 2019

Members received photographs of hanging baskets produced by Allan Evans & 5 Acre Nursery. Snowdonia Nursery did not submit any photographs. Members were reminded of the costs of baskets. Members feel strongly to support local businesses.

RESOLVED that Mr A Evans receives confirmation to provide the hanging baskets this year at a cost of £18.50 per basket.

iii) Schedule B Planning Applications – 0/45950

Councillor H Roberts informed Members that a letter had been written by a concerned resident regarding the conditions for the Trees proposed by Lidl at the site. Members advised Councillor Roberts to direct the resident to Planning, CCBC.

# 142. Planning

## a) Planning Applications

Members considered and commented on the attached Schedule B

Councillors M Priestley, H Roberts & E Roberts re joined the meeting at this juncture.

## b) Planning Decisions Issued

Members received a list of planning decisions issued by Conwy County Borough Council (Schedule C) The decisions were NOTED.

## 143. Conwy Classical Music Festival

Members received a request for funding for the 2019 Festival. Members praised the Festival. RESOLVED that Conwy Classical Music Festival is awarded a grant of £3000.

#### 144. Llangollen 2019

Members received a request for funding towards the Llangollen International Music Eisteddfod 2019. RESOLVED that Llangollen 2019 is awarded a grant of £50

## 145. Community Transport

Councillor S Barber-Bailey shared an idea for having a community bus similar to that of Pemaenmawr, Dwygyfylchi and Llanfairfechan. The bus would enable residents with no access to public transport the opportunity to get out and about, it could also be hired by local groups for outings at a reasonable cost. The bus would have to be run by volunteers. Members were made aware that the bus in Penmaenmawr and surrounding communities was specifically funded as part of the European funding for quarry communities. Councillor G Willetts will work with Councillor S Barber-Bailey to look into costings and will bring the item back to a future meeting.

#### 146. Improving/using the Cob

Councillor S Barber- Bailey shared an idea for using the Cob as a community space with possibilities of holding events, having markets and children's activities. Members felt that this is a valued open space and should not be micro managed. Members discussed planting bulbs/ seasonal bedding in the existing beds. It was felt that a group would need to work together to look at the item further.

## 147. Revised Statement of Gambling Principles - CCBC

Members NOTED the document emailed on 1/3/2019.

#### 148. Welsh Engagement Plan

Members discussed the email that was sent on 21/2/2019. RESOLVED that the Town Council do not participate at present.

Councillor E Roberts left the meeting at this juncture.

## 149. Independent Remuneration Panel for Wales

The Town Clerk informed Members that there are significant changes to the way in which the £150 allowance for Members is issued. Members were also informed that there are changes to the Mayoral allowances. The Mayor thanked the Town Clerk for looking into the matter of allowances and for clarifying the Mayor's allowance.

RESOLVED that the item is discussed further at the Finance Committee Meeting to be held on 27/3/19 and then brought back to a future agenda for discussion.

#### 150. Gladstone Benches

Members discussed the correspondence from Delyth Crisp at CCBC regarding the Gladstone benches. CCBC had found no evidence of a paper trail indicating that Conwy Town Council had agreed to purchase the benches. However, if the Town Council want the benches to remain in place then CCBC are happy to accept a lower price of £750 + VAT per bench, as opposed to the original price of £1,100 + VAT together with an installation fee. It was unanimously agreed that the cost of the benches at £1,100 + VAT was an unacceptable amount of tax payer's money to spend on benches. The quality of the benches was not disputed. A discussion also took place in relation to removing the Gladstone benches so that Conwy Town Council could place affordable benches in the square.

RESOLVED that the Town Council go back to the County Council with a counter offer of £500 per bench to include VAT and if not accepted to inform them that Members would be happy for Conwy County Borough Council to remove the benches and Conwy Town Council would look for a more affordable replacement set of benches.

NOTED:

- 9 Councillors voted in favour of the counter offer of £500 including VAT.
- 4 Councillors voted against and would like the benches removed in order that Conwy Town Council can place more affordable benches in the square.

#### 151. Wales in Bloom

Councillor B Chapman informed Members that it was suggested by P Barton Price, Green Spaces Manager, CCBC. That Conwy Town Council enter Wales in Bloom Competition. Councillor B Chapman explained that the competition is not only about floral displays, it also looks at community involvement. Members support the idea and are happy to pay the entry fee of £205 for a large Town. Councillor B Chapman has offered to fill the form in.

RESOLVED that the Town Council enters Wales in Bloom at a cost of £205 and Councillor B Chapman fills the form in.

# 152. CADW Parking

Members received details of several complaints by residents regarding vehicles parking by the Castle walls on the grass verge, next to the steps that go down to Morfa Bach Car Park. Members were informed that the vehicles are owned by the staff of the Castle.

RESOLVED that the Town Clerk contacts CADW for clarification on the use of the land for parking and informs them of the recent complaints.

#### 153. Conwy Town Post Office Closure Notice

Members were concerned and saddened that the Town will be losing a valued service, which will cause some difficulties for residents.

RESOLVED that the Town Clerk writes to the Post Master General to ask him to reconsider the Post Offices decision to close the Post Office in Conwy.
