135. Planning

a) Planning Applications

Councillors Hart & James left the meeting during discussion of application 0/45044 Councillors considered and commented on the planning applications as shown on the attached Schedule B

b) Planning Decisions Issued

Councillors RECEIVED and NOTED the planning decisions issued by Conwy County Borough Council Councillors discussed the decisions being made by the County Council Planning Committee. Town Councillors who are also County Councillors said that they felt that there were not enough Members on the Committee & that attendance was poor. This meant that decisions were being taken by a small number of Members who were no representative of the area. Councillors also felt that there was not enough recognition of Town Council views & that they should be given more weight.

Councillors discussed the Planning Portal. Councillors found the system difficult to work with impairing decision making. Councillors said that they preferred to have paper copies & enquiries should be made as to the cost of obtaining these

137. Conwy Harbour Advisory Committee

Councillors received a report on the meeting held on 21st March 2018.

Councillors were concerned about the situation regarding the Mussel Fishery. A Regulatory Order is required to manage the fishery by CCBC.

RESOLVED that a letter is written to the Harbour Master, Chief Executive, CCBC & Cabinet Member for Regulatory Services, CCBC stating that the Town Council strongly supports the County Council obtaining the Regulatory Order & would consider contributing to the cost & help with other resources.

Councillor Vaughan left the meeting at this juncture

138. Pedestrian Access to Conwy Town Centre

Councillors received correspondence from a resident who was concerned about the safety of pedestrians walking through the archway on Llanrwst Road, Conwy.

Councillors agreed that this route was not safe. Councillors suggested that signs could even state "You Could be Killed" & should be multi-lingual

RESOLVED that a request is made to the County Council for signage to be put up stating "No Pedestrian Access" in the area & "Access to Conwy Town" signs are put up on the road & car park. Local members are to be included in the decision making.

139. Call Out for Projects for Locating Renewable Furniture in Your Rural Community

Councillors received information on the scheme. Councillors felt that benches on Lancaster Square & Conwy Quay would benefit tourism. 80% funding is available for projects

RESOLVED that the Rural Enabling Officer, CCBC is invited to a meeting to discuss the scheme
