291. Civic Hall & Quay, Conwy (changed place on agenda with Land Dev in the comm)

No viable bids had been received. The Civic Hall will now be offered on the open market without the restrictions previously put in place.

The County Council want to keep up Town Council up to date with matters

The timeframe for new bids and decisions has not been set. Ms Richardson understands that the property will go out onto market in a few weeks eg early May. There will be approximately a month to six weeks for tender period but is not sure if that will start before or after the elections.

The County Council has to realise capital receipt from building so can go ahead with cultural hub. Councillors thanked visitors for coming & for coming back to provide update.

292. Land Development in the Community

Mrs Wendy Dearden, Conwy County Borough Council, gave a presentation on affordable housing in the community. Affordable Housing is the remit of both Strategic Planning Policy & Housing Officers. The Local Development Plan (LDP) is currently out for review. There will also be supplementary planning guidance which will give percentage of affordable housing needed. Affordable Housing describes both Social Rented and Intermediate Housing, as well as specialist provision. Intermediate Housing includes Intermediate Rent and Low Cost Home Ownership. Conwy Town Council is within Llandudno area, which has a ratio of 6.5 for household income:house price. 11% of Conwy's housing stock is available for social rent, which is the second lowest for a county in Wales. Conwy Town Council area has 10% of the county's Social Stock, with a small number of one-bed properties & a very limited social stock of larger houses (4+ bedrooms). There are currently 1002 applicants on the Conwy Register; to join the register an applicant has to be 'in housing need'. 17% of Conwy residents rent privately, which is the third highest proportion in Wales (there is a larger private rented stock than social rented stock). With

Welfare Reform, the Local Housing Allowance is the maximum amount of housing benefit that can be received if benefit dependent. There are gaps between local cost of housing & housing allowance. In 2018, caps will come into the social sector as well as the private sector. There are 1580 Empty Homes in Conwy (ie empty for more than six months), as well as 1100 second homes used for holidays. Welsh Government has allowed councils to charge a Council Tax premium of double rates for second homes. Conwy County Borough Council is not going to be introduced in April 2017, & will reconsider it in April 2018. A Local Housing Market Assessment is carriet out every two years. The current Assessment states that Conwy County need 199 new homes per year. Last year there were 85 new Affordable Housing Units delivered in Conwy County. 1 in 5 of the houses in Conwy County is occupied by a lone pensioner. CCBC is:

- making the case for affordable housing, including land put aside in LDP for predicted population levels
- securing as much capital funding as possible
- renovation and conversion of empty properties (Empty Homes Officer, Jeremy Grant)
- supporting housing associations

Councillors thanked Mrs Dearden for the presentation & work over the years.

299. Car Parks

Members received feedback from the meeting with Conwy County Borough Council Officers held on 3/3/17. Information requested at the meeting has not been received from CCBC Officers. RESOLVED that the Town Clerk request the information.

300. Fencing & Gate at Bron Vardre Avenue, Deganwy

Members received a request to assist with funding for a new fence. The land is owned by CCBC. Local Councillors have spoken to local residents who have said that they do not want such a fence. It is not clear that it is dangerous.

RESOLVED that the Council respond that there is no money available in budget this year for this request; to be considered in the new financial year, three quotes should be provided.

301. Tree Charter

Members received details of the Charter which the National Association of Local Councils is promoting throughout the UK. The aim is to promote planting, growing and protecting of trees. There is no cost to becoming a member. It can be used in commenting on planning.

RESOLVED to join and become a Charter branch.

302. Conwy Harbour Advisory Committee

Members received a report on the meeting held on 22/3/17.

Some dredging has been completed; there will be a need to do more.

There has been a successful tender for two years of maintenance of the markers on the NE side of the Strait.

Annual servicing of moorings in Conwy is taking place.

The Harbour wish to take charge of the Event Space and to keep any revenue (from 1/4/17).

There is a defibrillator in the red phone box adjacent to the public toilets on the Quay.

303. Ysgol Awel y Mynydd

Members received updated information that the school will open in September 2017 rather than May 2017, mainly due to problems with the drainage.

304. Llandudno Junction Regeneration Scheme

Members received a report on a recent meeting about land at Mackinley Road; it is currently used for parking by local residents but there is a proposal to sell it. The majority of on-road car parking space in Llandudno Junction is no longer available & most houses do not have off-road car parking.

RESOLVED to invite V Turner, CCBC to come to a meeting about parking availability for residents in Llandudno Junction

Broad Street regeneration is waiting for funding. Brickworks proposed development is ongoing.

305. Independent Remuneration Panel for Wales – Annual Report

Members received the Annual Report with Determinations. Councillors noted that it was important not to preclude anyone standing or serving on Council due to financial constraints.

RESOLVED to adopt the eight Determinations contained in the Annual Report relating to Town & Community Councils

Councillors who wish to claim expenses for 2016/17 must return a completed expenses form. Councillors who are not submitting an expense claim must submit a letter to confirm that.

306. Conwy Quay Defibrillator

Members received information regarding the RNLI request for funding & the cost of a defibrillator at the lifeboat station.

RESOLVED to donate £1000 to the fundraising.

The Town Council would appreciate a mention in press releases by the RNLI about the defibrillator.

307. Conwy Borough Football Club

Members reconsidered a grant application from Conwy Borough Football Club following receipt of further information on the cost of a mower. To make a new decision on the grant application, the Council's previous decision not to grant a donation needs to be rescinded under the six month rule. RESOLVED to rescind the previous decision, with the signatures of over 10 Councillors RESOLVED to make a donation of £500

Members received the business rates demand for 2017/18 of £6,611.75 RESOLVED to approve payment of rates

309. Avensure

Members received information on the 20% discounted payment available if a single payment is made upfront instead of monthly payments for the remainder of the contract. The amount payable is £1,338.72 including vat
